

## ONTARIO 360'S SOCIAL POLICY AND OPPORTUNITY ROUNDTABLE WITH JENNIFER ROBSON: IMPROVING ACCESS TO POST-SECONDARY EDUCATION

Opening Remarks by Meric Gertler, President of the University of Toronto

Thursday, April 26, 2018

Thank you, Peter, for that kind introduction. Thanks also to Rudyard Griffiths for inviting me to join today's discussion. Good morning, everyone, and welcome to the University of Toronto.

I know we are all looking forward to Professor Robson's presentation and the conversation to follow. The topic is of particular interest to those of us directly involved in the sector. It is also of great importance to our broader society.

As Canadians, we justly celebrate our standing among the world's most educated countries. At the same time, we have a shared obligation to ensure equity in access to higher education, so that the opportunities it makes possible are widely shared. Nowhere is this responsibility more evident than in a place like Toronto, where more than half of the population has come here from around the world in search of opportunity.

For its part, U of T is strongly committed to this objective – and we too are justly proud of our record of leadership in ensuring access for all qualified students, regardless of their personal financial means. Thanks to our 20-year-old access guarantee, more than half of our domestic undergraduates receive needs-based financial aid, which reduces the cost of their education significantly. Our current Boundless Campaign, and its predecessors, have succeeded in raising an endowment for student aid that now exceeds \$1B.

In addition, every year, hundreds of our students work in the city's low-income neighbourhoods, tutoring and mentoring high-school students and helping them to raise their educational aspirations. But we remain acutely aware that there is still much more to be done, as Professor Robson argues so compellingly in her report.

Higher education remains one of the most important determinants of our prosperity, and one of the most potent drivers of social mobility. Because of its
