Ontario 360 delivers on its 30-on-30 initiative – 30 evidence-based policy ideas for Ontario in 30 days

TORONTO—The *Ontario 360* project, housed at the University of Toronto's School of Public Policy and Governance (SPPG), marks the successful wrap-up of its 30-on-30 initiative this week.

Over the month of April, *Ontario 360* released daily "transition briefings" by leading policy experts on a wide range of topics – including affordable housing, manufacturing, taxes, poverty, democratic reform, and so on. These commentaries set out evidence-based analysis and clear, actionable policy recommendations that can find broad-based support.

The result is an inventory of evidence-based policy recommendations for the political parties to draw from for their respective policy anyplatforms, and to ultimately inform the incoming government's policy agenda. "The 30-on-30 initiative has exhibited SPPG's unprecedented convening power," said Peter Loewen, SPPG's director. "We've been able to bring together leading policy experts and practitioners to contribute to a comprehensive, evidence-based governing agenda for Ontario's next government."

This first phase of the *Ontario 360* project wrapped up with a successful policy breakfast on Wednesday, May 2, with a panel of expert contributors – including Linda White (early childhood education and care), Matti Siemiatycki (infrastructure), and Jack Mintz (taxation) – and a diverse group of Ontario public servants and members of the broader public policy community. The event was a good example of the constructive and rigorous policy dialogue that the project is aiming to catalyse.
